- 3. The draft minutes of Ide Parish Council meeting held 12 October 2022 were approved and signed by the vice chair
- **4. COUNTY AND DISTRICT COUNCILLORS' REPORTS:** Councillor Connett reported that DCC were looking at a £30 million overspend in the current financial year, mainly due to increased energy costs and social care funding. This is expected to rise to 70 million next year and DCC are awaiting the Government statement on funding due later this month

The following report from Councillor Andy Swain (TDC) was read out by Councillor Ervine

"The Task and finish group which I chaired, looking for ways to improve enforcement in Teignbridge will make its final report to Overview and Scrutiny next week. I will be happy to circulate the report to parishes if it is approved. I would like to thank all the parishes for responding to the investigation.

Unfortunately, the backlog continues to be a problem. I have, today contacted officers about the round-field enforcement. It does seem to me that this industrial use in a location so explicitly protected from that use in the local plan should be an open and shut case for refusal. I have shared that view with the officer"

- 7.1 Ide Community Orchard WG The chair, thanked Peter Cloke for his report. (Paper1) Working party dates have been set for the planting of bulbs, still lots of apples to be picked. The management group will be organising other activities for the coming year.
- 7.2 Weir Meadow & Northern Fields WG The chair, thanked Richard Cottle for his informative report (Paper 2) The group met on Tuesday 15 November 2022 and the group requested approval for the flaying (estimate of £1600) of the area known as Oak Bank, the young oak saplings will be identified and protected. This will allow an area where dogs can be exercised off the lead. IPC sanctioned this request.

- 7.4 Ide Emergency Planning WG verbal reports P.B-P/BE
- 7.4.1 Drainage/flood prevention report an appeal to keep the gullies free of debris and leaves was made in the November Ide Times. The working group is due to meet soon, to prepare for any winter ice and snow emergencies, sand/grit and salt supplies have been checked a will take place shortly nd additional supplies ordered. Some storm gullies were recently cleaned by Devon Highways. Clearing of the storm drain has been requested. A meeting will take place shortly of the volunteers. A request for a grit bin at the Earles Court corner will be remade to Highways. ACTION P-BP and BE
- 7.4.2 Removal of vegetation on A30/Ide Village Road new planting progress report P.B-P No further updates received
- 7.5 Ide Climate Emergency and Environment WG AS no actions reported
- 8. Grass verge surrounding War Memorial MT proposed the motion to put in signage and/or a cordon surround to deter car parking on the grass. Recently parking has taken place on these verges, old photographs show that a low post and chain barrier were previously installed to protect this area. Clerk to investigate cost of re instating these barriers for inclusion in next year's budget.

The councillors also approved the purchase of a new laptop (budget £500) Proposed NC and seconded RH ACTION ML TO PURCHASE.

- 10.3 Draft budget proposals for April 2023/March 24 Paper 5 were fully discussed, the councillors considered it prudent to increase labour and material costs by 8%, ML to rework the figures for the budget and present for approval to the January meeting. ACTION ML TO REDRAFT THE BUDGET PROPOSALS

Councillor Thomas has met with one of the governors of the school, who are seeking closer liaison and support from IPC. The school governors are applying funding to improve the preschool building.
