IDE PARISH COUNCIL

DRAFT MINUTES OF A MEETING held on WEDNESDAY 22 MARCH 2023 at 7.30pm in IDE MEMORIAL HALL

Present: Councillors Nick Bradley (chair), Mark Thomas (vice chair), Andy Swain, Jessica Paine, Paula Burton Perrett, Ben Ervine, Laura Bell and Nick Creasy (arrived 7.40pm).

In attendance: Mel Liversage, clerk, and 1 member of the public.

The Clerk announced that the meeting will be audio recorded.

There were no representations from the public about matters on the agenda or for future agendas.

- 1. APOLOGY for absence received from Cllr Rachel Herbert who was unwell. Apology accepted.
- **2. DECLARATIONS OF INTEREST:** Cllr Burton Perrett declared an interest in item 5.2 as the householder living at 12 High Street.
- **3. THE MINUTES** of Ide Parish Council meeting held 25 January 2023 (see website) were approved and signed by the chair.

4. COUNTY AND DISTRICT COUNCILLORS' REPORTS (written or verbal)

Cllr Swain informed the council that he will not be standing for election as a Teignbridge District Councillor on May 4 2023. The chair thanked him warmly for his work as our TDC councillor for the past four years. The chair introduced John Parrott who will be standing for election for Kenn Ward.

I'm writing about the planning case at the Round Field site in Ide.

New (Retrospective) Application

22/00826/FUL Land at NGR 290858, 90284, Ide, Devon (Round Field)

This retrospective permission was received and validated on Thu 21 Apr 2022 after Ide parish council raised concern that the container storage activity being carried out there is unpermitted and in flagrant breach of Ide neighbourhood plan policy IDE07.

The case is still showing as "Pending". I would have thought this was an open and shut case for refusal since it exactly violates a neighbourhood plan policy specifically created to prevent exactly this. There is an Ide Parish council meeting on 22 March and I would very much like to give an update. On that day it will be more than 11 months old. I have made this case several times over the last year.

Needless to say, since it is pretty clear that a breach is occurring and this is a retrospective application, the applicant is continuing meanwhile and will not be in any rush to resolve the case, but the community needs it resolving. Some in the community have suggested that once this is resolved TDC will have an enforcement problem, so TDC may be minded to delay. I have reassured them that I do not think TDC would do that as I am sure you would not.

It is on the site of the proposed Park and Ride which was a huge source of tension between the Ide community and local council services, and was the reason Policy IDE07 was created to protect this site.

It also lies adjacent to the C50 where the community were promised footpath widening and upgrade to a cycle path as part of planning application 18/01024/MAJ. The parish council opposed this development but the footpath upgrade was welcomed. The application was approved, but subsequently the applicant requested the footpath condition be

dropped 22/00452/MAJ | Removal of condition 5, and TDC agreed, despite strong opposition from the Parish council.

It is also right on the boundary of the Markhams village site where Teignbridge is asking the community to accept 900 houses, and is promising infrastructure, services and green space all of which will need to be enforced by TDC planning.

It seems important to improve the credibility of TDC Planning. The experience for the local community recently has been quite poor.

I hope we can see some progress on this case soon, and I would appreciate an update before 22 March.

6. TEIGNBRIDGE LOCAL PLAN 2020-2040 - Proposed Submission (Regulation 19) Version

The chair reported on the Public Meeting held 3 March, 2023, and the subsequent representation submitted by IPC (see Ide Village website for full text). 83 residents attended. NB thanked Councillor Thomas for organising, equipping and chairing the meeting so effectively. NB reported that the mood in Ide was one of dismay at the proposal for a new village, Markham Village, of 900 houses to be built in the parish. Teignbridge officers put the case for the national need for houses, government policy for annual housebuilding targets, the lack of land and brown field sites in the district, and the numbers of commuters coming to work in Exeter from Teignbridge. Arguments were mounted from the floor against the proposals, principally on the grounds of conflict with Ide Neighbourhood Plan;

the lack of an agreed, detailed transport and traffic scheme to answer the problems of this particular site; and the loss of prime agricultural land, of great landscape value, which forms the green backdrop to Exeter. Other concerns about sustainable travel on cycle and foot; about flooding and the strain on the sewage system; and on the apparent absence of cooperation between neighbouring authorities were also advanced. The next step will be the Inspector's examination in public of the Local Plan submission version. The chair has stated that he would be willing to speak at the hearing.

The Councillors then discussed the merits and costs of employing a barrister to represent the village's views at the hearing; or at least seek a counsel's opinion on the strength of our case ahead of the hearing.

We would like to gauge the level of financial support there would be in the village for a potential fighting fund to pay for expert legal advice and representation. We discussed using a Facebook poll; and the possibility of raising funds by direct appeal to residents were there support for this.

ACTION NB

In the first instance, the Chair will seek advice from local lawyers already active in the life of the community, about how best to seek a counsel's opinion, and the likely costs we might incur, before asking residents for their views on providing financial support for this work.

14. PINCHPOINT ABOVE ENTRANCE TO THE HAMS, ON THE GREEN ML

Three traffic cones and notices have been erected on The Green to deter parking at this pinch point and an application to Devon CC Highways for double yellow lines has been made. Councillor Connett is supporting this application. It may take some time for this to be implemented.

15. COUNCILLORS' REPORTS and items for future agenda.

Cllr Bell has attended a virtual "20 is Plenty" training session. Only 4 or 5 applications out 150 have been approved so far in Devon. She will contact our immediate village neighbours; a combined villages campaign might carry more weight together, to get the implementation of the scheme.
