6. Teignbridge Local Plan 2020-2040 – Proposed Submission (Regulation 19) Version

The chair reported on the Public Meeting held 3 March, 2023, and the subsequent representation submitted by IPC. 83 residents attended. NB thanked Councillor Thomas for chairing the meeting so well. The mood was one of dismay in the village having plans proposed for 900 houses alongside the village. Good arguments were put forward as to why this was not appropriate. The next step will be the Inspector's examination of this Plan, The chair has stated that he would like to attend this meeting.

The Councillors discussed the need to employ a barrister to represent the village at the hearing.

Please see TDC website for the full text of the PC's submission. The three key planks of our objections were:

- Neighbourhood Plan no account taken of policies IDE01 (housing development) and IDE07 (Ide Gateway Enhancement Area);
- Transport no scheme proposed to deal with major highway congestion, improving rail use, or cycling and walking provision;
- Landscape no account taken of green backdrop to Exeter, Area of Great Landscape Value, or unnecessary use of high grade agricultural land.

We plan to gauge the level of financial support there would be in the village for a potential fighting fund to pay for expert legal representation at the examiner's hearing, having discussed the need for a Facebook poll with the residents voting for this action, and the idea of raising the monies from individuals.

ACTION NB The chair will ask for an opinion from a local resident barrister to see whether there is a need for us to employ a barrister or whether perhaps a Local Plan specialist might be more appropriate, before asking the villagers for their views on this and or ask for their financial support for this work.
