### **6.1 New Applications**

**23/01955/HOU 7 Cross View Terrace Ide EX2 9RZ:** 2 storey rear extension. The committee decided to object to this application: we considered that the proposed two storey extension is excessive and would adversely affect neighbouring properties, leading to privacy loss and overshadowing; that the extension's size would alter the character of the whole row of

houses in this vicinity. We also had concerns about the limited accessibility of the property for development work, given the absence of road access and only a footpath available: this could pose challenges and potentially disrupt the neighbours.

### **23/01924/OUT IDE - Land North of College Lane, Ide Lane EX2 9TF**

Outline application for three dwellings and associated works; approval sought for access purposes only. The Planning Statement makes light of the conflicts with Ide Neighbourhood Plan, although it conflicts with every element of Policy IDE01:

- it's outside the settlement boundary
- it's not infill in a small restricted gap in the continuity of existing frontage
- it's not closely surrounded by buildings
- it's not a redevelopment site
- it's not within a built up area of the village
- it does encroach significantly into the countryside
- the access is off a fast 60mph main road
- it does not seek to enhance the character of the unique conservation area of listed cottages in The College
- it does not provide one small dwelling (2 or less bedrooms) for every larger dwelling (3 or more bedrooms)

The statement refers to College Road and Ide Lane, instead of College Lane and Ide Village Road respectively.

The planning committee has requested deferral of the deadline for comments to allow consideration by the full IPC, when it will recommend objection. **BE Paper 2**
