4. CURRENT PLANNING MATTERS

4.1 New Applications

23/02157 IDE - Land Off Whiddon Lane, Ide Change of use of land for use as secure dog walking field for private hire and creation of associated area for parking.

The committee were concerned that the land is off Idestone Lane **NOT** Whiddon Lane as stated on the application form and we wish to clarify this with TDC before sending in our comments.

We commented that with the potential increase in traffic on Idestone Lane, on what is a single use lane with very few passing places, we would like to see the highways agency report on this application before sending our comments.

"The NPPF at paragraph 111 advises that development should only be prevented or refused on highways grounds if there would be an unacceptable impact on highway safety, or the residual cumulative impacts on the road network would be severe."

We feel there is a potential for this and it should be investigated further before any decision is made as this road isn't classified A, B or C as far as we can tell.

ACTION We will request a deferment of our comments on this application until TDC have confirmed that the correct address is shown on the application form and we have read the Highways report.

Added on 6 February: After the chair of Ide Parish Council wrote to TDC pointing out that the wrong address is on the application, the address was changed with the applicant's permission and a new notice was issued under the existing application number 23/02157/FUL giving an extended date of 27 February 2024 for comments. The Planning Committee will reconvene to discuss the amended application and will advertise the

meeting to allow the neighbouring landowners and residents to comment or attend the new meeting.
