# 5.2 Applications awaiting a decision from TDC

5.2.1 23/02157 FUL - Land off Idestone Lane, Ide. Change of use of land for use as secure dog walking field for private hire and creation of associated area for parking. Ide Parish

Council, the CPRE and 33 individuals have objected to this application (see previous minutes). Following requests to call in the application, TDC Planning Committee are to debate it on 14 May 2024.

5.2.2 23/00463/FUL - Stevens Farm, Ide, EX2 9FB: Change of use of agricultural building and land to commercial use for the sales and maintenance of tractors. Objected to by IPC Planning Committee.

# 5.2.3 **24/00432/MAJ** - Pynes Farm, High Street, Ide Demolition of existing buildings and the erection of ten dwellings, associated access, parking, and landscaping.

An extraordinary Parish Council meeting (see published draft minutes) was called by the chair on Tuesday 9 April 2024 to discuss this application by Heritage Homes. Two representatives of Heritage Homes attended the first part of the meeting to take questions. Eight members of the public also attended.

Whilst remaining warmly in favour of residential development of Pynes Farm Yard to provide ten homes, Ide Parish Council has objected to the application because the proposed housing mix of two x 4 bedroom homes, seven x 3 bedroom homes and one x 2 bedroom home differs from the housing mix for the ten homes approved by TDC for the site in 2021, a mix that was compliant with Ide Neighbourhood Plan: two x 4 bed, three x 3 bed and five x 2 bed. This new application does not comply with the stipulation for one smaller home (1-2 bedrooms) for every larger home (3 or more bedrooms) set out in Ide Neighbourhood Plan, policy IDE01, para iv. Councillors were content with the provision of two affordable homes in the new application, the same as previously approved in 2021. It was noted that there had been a Section 106 agreement in the 2021 permission setting out in detail the definitions of affordable housing and local resident, thereby meeting the demographic needs of the village. The new application does not meet the spec we set out in 2018 for a housing mix that would provide smaller accommodation for first time buyers and for older residents downsizing.

We have also requested a review of the capacity of the planned surface water drainage scheme; and asked that deliveries of building supplies be limited to outside school drop off and pick up times, to avoid gridlock in Fore Street and High Street
