

IDE PARISH COUNCIL

DRAFT MINUTES of an EXTRAORDINARY MEETING HELD on WEDNESDAY 18 DECEMBER 2024 at 7.00PM in THE HUB, HIGH STREET, IDE

Present: Councillors Nick Bradley (NB), chair; Mark Thomas (MT), vice chair; Rachel Herbert (RH); Paula Burton Perrett (PB-P); Nick Creasy (NC).

In attendance: Mel Liversage, clerk. No members of the public were present

The proceedings were audio recorded.

1. Apologies: were received from Cllrs Ben Ervine, Patrick Irwin and Sarah Tiley, due to other engagements – apologies were accepted. TDC Cllrs John Parrot, Charles Nuttall, Kevin Lake and Alan Connett (DCC) also tendered their apologies.

2. Declarations of Interest: There were no declarations of interest

3.1 Discussion of HATOC proposals for Ide contained in the Devon County Council (Teignbridge HATOC - Highway and Traffic Orders Committee) 6141 [DPS:NL:DEV001/979:B].

3.1.1 Proposed parking restrictions for the entrance to the village, Figure No ENV6141-459 for No Waiting at Any Time double yellow lines at Fore Street, Ide.

Background: The Chair reported that we had missed the October 2024 deadline for comments, and the 14 November HATOC meeting, through an oversight; and that the parish council and residents had not had the chance to discuss Devon Highways' proposals. The Parish Council had previously requested restrictions on the eyebrows at the entrance to Fore Street off Ide Village Road (IVR) some years ago. Our grounds for this were, and remain, to restrict parking a) to improve safety at the junction, and b) to prevent blockage where Fore Street narrows 25 metres or so south of the IVR junction line.

He confirmed that Devon Highways officers and Cllr Alan Connett have allowed our request to send in comments late, which will be considered at the next HATOC meeting; and that the proposals will not be enacted until then.

Councillors agreed on the need for a balance between traffic safety and parking space in Ide. We agreed that the proposals are more extensive than expected and than required: the most southerly parts of the restriction lines on each side should be reduced as shown on the amended plan, which forms part of these minutes (Fig 1 below).

RESOLVED to request an amendment to DCC's recommended proposal, by reducing the restrictions on each side. Fig 1 below is an annotated amended plan showing with cross hatched markings the sections on each side that we suggested should not be painted with yellow lines.

ACTION ML/NB TO RESPOND TO DCC

3.1.2 The order for The Green, opposite numbers 2 & 3, was amended at the HATOC meeting of 14 November, following suggestions submitted by residents of The Green and the chair - to shorten the length of the yellow line on the western side to match those on the east - and will be implemented.

4. The next meeting of Ide Parish Council is on Wednesday 15 January 2025 at 7.30pm to be held in Ide Memorial Hall

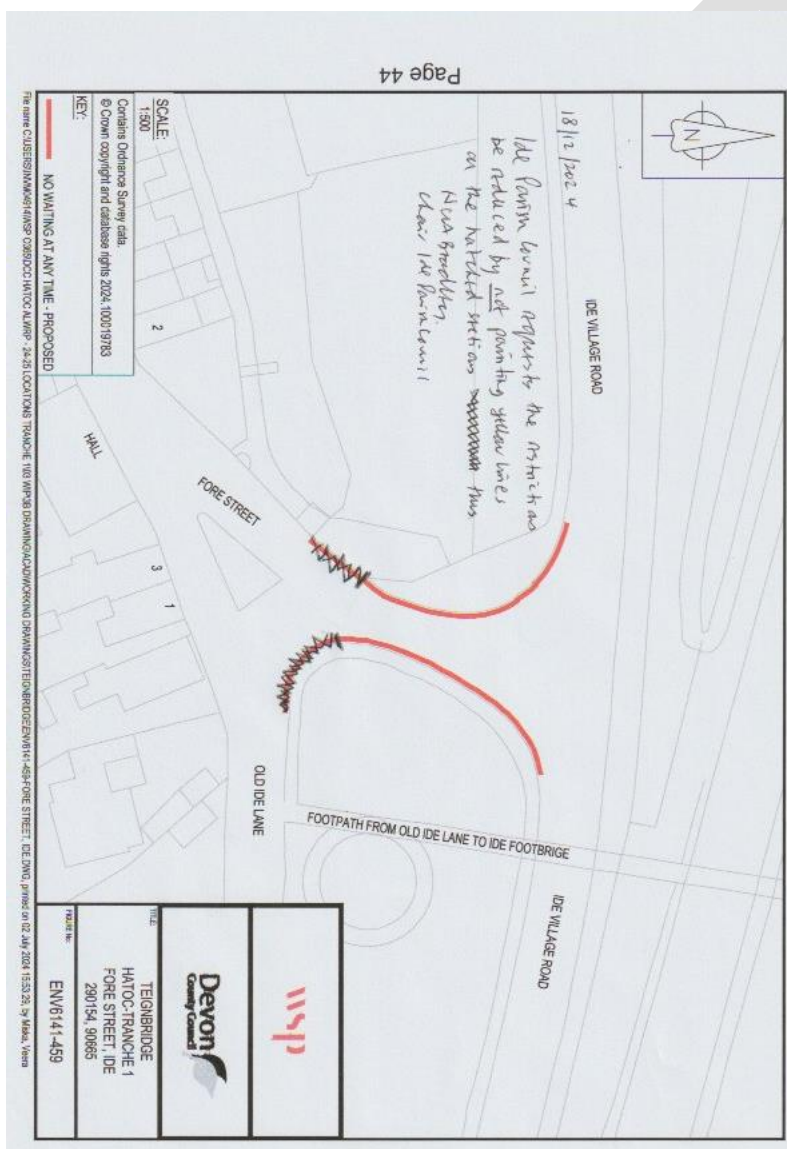
